

Community Service Order Regulations 2002

THE COMMUNITY SERVICE ORDER ACT 2002

**Regulations made by the Minister under section 11 of the Community Service Order Act
2002**

1. These regulations may be cited as the **Community Service Order Regulations 2002**.
2. In these regulations -

"Act" means the Community Service Order Act 2002;

"Central Probation Committee" means the Central Probation Committee established under the Probation of Offenders Regulations 1947;

"District Probation Committee" means the District Probation Committee established under the Probation of Offenders Regulations 1947;

"supervisor" means any person designated by the institution providing a work placement to the convicted person.
3. (1) The Central Probation Committee and the District Probation Committee shall supervise the overall work in connection with community service order under the Act.

(2) The overall supervision of persons subjected to a community service order is entrusted to the Probation and After Care Service.
4. The institutions offering work under a community service order shall be the institutions specified in the First Schedule to the regulations.
5. The institution offering work under a community service order shall be responsible for the monitoring of work performance and attendance at the place of work.
6. The travelling time spent by a convicted person from his home to the work site shall not be considered as working time under the order unless the community service officer decides to consider all the time so spent or part of it.

7. (1) While performing work under a community service order, the convicted person shall comply with any reasonable direction given by the community service officer or supervisor as to the way the work- has to be performed, having regard to the specific work place and the interest, security and well being of persons who can be found at such place.
- (2) Where a convicted person -
- (a) fails to comply with a direction specified in paragraph (1);
 - (b) fails to perform work as instructed;
 - (c) behaves in a disorderly, or disruptive way, or any manner likely to do harm to members of the public or any person for whose interest work is being performed;
 - (d) reports at work later than the appointed time,
- the community service officer may require the convicted person to cease work and leave the place of work forthwith.
8. The institution providing work placement shall submit a report on convicted persons employed by it on the prescribed form set out in the Second Schedule to these regulations.
