MAURITIUS CITIZENSHIP ACT

FACT SHEET No. 6

Section 14(2) – Registration as citizen of Mauritius of a person who has ceased to be a citizen of Mauritius following renunciation of Mauritius Citizenship

1. A person of full age and capacity who has ceased to be a citizen of Mauritius upon making a declaration of renunciation may apply for registration and resumption of Mauritius citizenship under this section.

HOW TO APPLY

2. Application Forms are available at the Citizenship Section of the Prime Minister's Office, Level 4, Government Centre, Port Louis, Tel Nos 201-1495; 201-3362; 201-2208 or on the following website: pmo.govmu.org.

APPLICATION PROCEDURES

3. The duly filled in application has to be subscribed in Mauritius, in the presence of a Judge or the Master & Registrar of the Supreme Court or a District Magistrate, prior to submission.

4. The following supporting documents in original and one photocopy should accompany the application (clean and legible copies on A4 format):-

- (a) *A recent full/ unabridged birth certificate of applicant (duly apostilled if applicant was born abroad);*
- (b) *Birth Certificate of applicant's parents (duly apostilled in country of birth if born abroad);*
- (c) *marriage certificate of applicant (if applicable, duly apostilled if marriage was celebrated abroad);*
- (d) *certificate of foreign nationality; and*
- (e) *documentary evidence to the effect that applicant's marriage has been dissolved or the spouse passed away, or applicant had been abandoned by the spouse.*

NOTE: Any change of name should be made executory in Mauritius.

5. A non-refundable application fee of Rs 2,000 should be paid upon submission of the application.

6. Upon approval, **a prescribed fee of Rs 8,000 is payable** at the Cash Office of the Prime Minister's Office, Level 2, Government Centre, Port Louis and thereafter the Certificate of Registration is issued within one week.

7. If the application is not approved, the applicant is notified accordingly by way of a letter.

VALIDITY OF A CERTIFICATE OF REGISTRATION

8. A Certificate of Registration issued under the Mauritius Citizenship Act is valid for an indefinite period but it should be kept safely as **no duplicate** is issued in case of loss.

DEPRIVATION OF CITIZENSHIP

9. Any person who has acquired citizenship by registration may be deprived of that citizenship if the registration has been obtained by means of fraud, false representation or the concealment of any material fact.

NOTE

- Only a complete dossier with all relevant documents will be accepted.
- Processing of applications **generally** requires 12 months.
- No reason will be given for the refusal of any application under the Act.
